Off-Road Fuel Tax Recovery Program

About the Program

The Government of Alberta provides tax exemptions and rebates on clear fuel consumed commercially off-road at a rate of 9 cents per liter for diesel / gas & 6 cents for propane.

Off-road is defined as any road that is not maintained by federal or provincial governments, Including private property, oilfield lease, construction sites, logging and bush roads. As well as time spent working, idling, loading and unloading . . .

For Example:

. . . If you haul Crude Oil, LPG, or Production Fluids you are entitled to 42% of your fuel consumption as off-road, assuming you burn 10,000 liters of fuel per month x 12 months @ 42% X the tax rate of 0.09 cents per liter you would receive \$ 4536 per year. We can file a fuel tax rebate for 3 years prior - Plus the current calendar year.

Our Rates & Services

Our NO RISK RECOVERY PROGRAM ensures that you do not pay for our services unless we recover a rebate on behalf of your company. We only require some basic information about your business and its off-road operations in order to file for your Fuel Tax Rebate. Depending on how, or if you have filed a claim in the past we will do all or some of the following on your behalf.

- Provide and assist you with the documentation required for either program.
- Register you company for the appropriate fuel tax program.
- Reconcile all your fuel purchases according to the government guidelines.
- Complete and submit the required forms.

We have developed a positive relationship with the Alberta Tax & Revenue Administrative. And have been actively involved in and aware of the changes to the Fuel Tax Rebate Programs, adapting our forms on a regular basis in an effort to simplify the process of filing a successful claim on your behalf.

Our fees are based on a contingency basis upon receiving your rebate we will send you an invoice for the agreed upon percentage of the recovered amount. - once we receive payment for our services, we will release the cheques to you.

If you decide not to follow through with providing us the required documentation we will invoice you for the time spent on your claim at a rate of \$ 35.00 per hour.

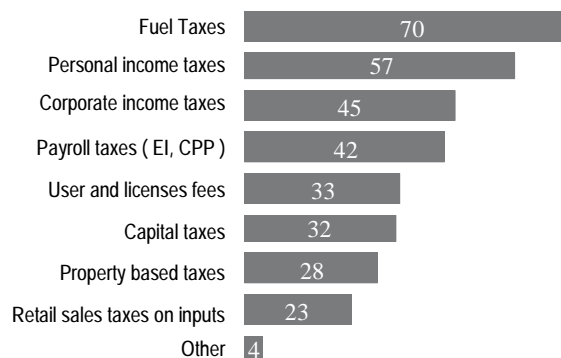
